## *Faq*

frequently asked questions

**1. Who will actually photograph my wedding?**

--I will be the primary photographer for your wedding; in addition I may sometimes suggest a second photographer for larger events.

**2. Is there any extra charge for doing some black and white?**

--No. All photographs can be printed in either color or black and white and in a variety of paper materials.

**3. How long until I can see my proofs?**

--Generally previews will be available 2-3 weeks from the wedding date.

**4. What kind of camera equipment do you use?**

We are currently using a high-end digital camera from Canon (8 mega pixels). The latest edition of digital cameras is the best medium of capturing the contemporary wedding.

**5. What are the advantages of using digital cameras?**

--Today's new digital camera technology has opened up many new creative possibilities. Not only has digital technology matched and surpassed traditional film in color rendition, sharpness, and versatility the new offerings of papers, albums, and presentation materials offer an unlimited range of options.

**6. What kind of clothing do you wear to a wedding?**

--Our policy is to dress as a guest at your event. Please inform us if your event will be black tie or otherwise.

**7. Do you travel, and are there additional fees involved?**

--Yes, we are available for domestic and international travel. We include up to one hour travel in the Waldorf area, additional travel time is billed \$30 per hour, and overnight travel stays will be quoted per event. Additional fees will incur for national/international travel (airline ticket, rental car, etc.).

**8. What type of payment methods do you accept?**

--We accept cash and checks.

**9. What if I want an item that is not included in your Estimate?**

--We have selected several products to suit our clients based on the quality and look to compliment our style of photography. However, if there is a certain item that you want and we do not carry, just tell us what it is, and we will find it for you.

**10. What is your style?**

**11. How many photographs will we get to see?**

--An average wedding yields to the area of 700 images. This number can vary depending on your schedule and preparation of the event. All images can be either Black & White or Color, and a wide variety of enhancements are available.

**12. When will our pictures go on to the Internet?**

--Your images will be available for online viewing and ordering in about two to three weeks from your wedding date.

**13. Can we have a virtual slide show on CD of our pictures?**

--Yes, CD slideshow presentation is available for your favorite images and album layout.

**14. What happens if I want a reprint, several years from now?**

--No problem, we will archive all your images for an indefinite period of time, so you can order Al A Carte products. A minimum order of \$50 is required for Al A Carte purchases after one year after the event.
